

THE CORPORATION OF THE TOWNSHIP OF JOLY

BY-LAW NO. 2014-12

Being a by-law to authorize the sale of land for tax arrears and to fix a scale of costs for the processing of properties.

WHEREAS the Municipal Act, 2001, as amended, authorizes the sale of land for tax arrears;

AND WHEREAS the Council of the Corporation of the Township of Joly deems it to be in the best interest of the ratepayers to fix scale of costs excluding actual disbursements and legal fees, in the processing of properties under Part XI Sale of Land for Tax Arrears;

AND WEHREAS the Council of the Corporation of the Township of Joly may also authorize the outsourcing of processing properties for the sale of land for tax arrears;

NOW THEREFORE the Council of the Corporation of the Township of Joly hereby enacts as follows:

- 1. Schedule "A" of Bylaw 2014-12 attached and forming part of this Bylaw be the sale of costs to be charged of proceeding under Part XI Sale of Land for Tax Arrears of the said Municipal Act.
- 2. That this Bylaw shall come into force and take effect upon passage.

Read a First, Second, and Third time, Signed and the Seal of the Corporation Affixed thereto and finally passed this 11th day of March, 2014.
