April 11, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, April 11, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe and Chris Nicholson; delegations Gary Blanchett & Linda Edwards; and Tom Bryson and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

### **Delegations:**

Gary Blanchett attended to advise Council he has been requested to provide a presentation on the history of the airport to Central Almaguin Lifelong Learning Experiences (CALLE) at the airport. Lynne Edwards from CALLE attended to explain their organization. Council will consider this further later in the meeting and the Clerk will advise of decision.

Al Nobes, Road Foreman attended to discuss and review the following:

- The past month has been spent mostly keeping up with conditions
- Starting to slope the edges of the surface treatment was discussed and Council suggested conducting a test first to ensure this will not result in break-up of the surface.
- Council requested the potholes be addressed as soon as possible.
- The area on Forest Lake Road where the surface treatment ends was discussed and the Road Foreman will look into cutting back the surface treatment to a more suitable location.
- The loader has been fixed however, upon inspection, the planetary gears are worn out with an estimated repair cost of \$ 5,000 to \$ 5,500. Used parts were discussed and will be looked into by both the Road Foreman and Councillor Brown.
- The sand pile in the municipal yard is starting to encroach on the neighbours property and will be pulled back as soon as possible.

The request from Budget Propane was discussed with the Road Foreman. The Clerk was directed to provide the requested correspondence to authorize this request.

The Road Foreman indicated he had contacted Mr. Mason regarding the comment form received. The Road Foreman will complete the comment form as directed.

Tom Bryson, Westwind Forest Stewardship attended to discuss forestry practices on Crown Land. Mr. Byrson provided a detailed power point presentation on the Managed Forest Program, covering all aspects of the program. The presentation was very informative and Council thanked Mr. Bryson.
