Councillor Brown removed himself from the table. Councillor Nicholson indicated he received a call from S Moss regarding this issue and therefore he contacted the Road Foreman and discussed options. Mr. Nicholson suggests removing the material from the area in front of the property (including before and after to allow for movement of road surface over time) and replace with quarried M. The Clerk was directed to discuss this with the Road Foreman. Council also authorized a maximum of \$ 1,500 of quarried M material to be purchased and used exclusively for this test location. This test to be completed as soon as possible to determine if this addresses the movement issues with this surface material.

# Staff Reports:

The following staff reports were reviewed and discussed:

- Road Department Proposed Work The Clerk was directed to request clarification on the training report provided. The Clerk was also directed to bring a list of training for the Road Foreman to the next meeting.
- Staff Report Upcoming Potential Quarry Expansion Councillor Brown declared conflict due to being an owner of a quarry in the Township.
- Signing Authority Application Modular Training The Clerk was directed to look into this further and bring back to the November meeting.
- Solar Report Council discussed what the solar panel has cost the municipality to date. With recently finding issues with the solar panel connections, improved revenues will lessen the overall cost.
